Increase in equity ownership in UMC Energy plc

Natasa Mining has increased its equity interest in AIM listed UMC Energy plc (UMC) from 20.58% to 89.99% as a result of the capitalisation of A\$2.4 million (£1,345,920) of UMC’s indebtedness to Natasa into 213,638,095 new ordinary shares of 0.5p each in UMC, equating to a conversion price per share of 0.63p.

UMC has an 80% interest in the Morondava uranium project in Madagascar, so Natasa’s indirect interest in this project will increase from 16.5% to 72%.
